Disclaimer and Terms: Paper Dolls is a website for women in the federal or state prison systems ONLY. All other applications will be disposed of. Request for this service, with or without an official application, constitutes acceptance of all terms and future revisions to the terms. **English only.**

Application fee is \$10 cash, check, or money order (20 first class Forever stamps accepted from state prisons in VA, FL, MD, and NC, plus KY for 2024-2025 ONLY). Stamps from other institutions will not be returned and applications will not be processed. You MUST send a self-addressed stamped envelope for a copy of your web page and/or photos back. We will provide a return envelope for \$1 (3 stamps allowed from institutions listed above). **Photos must be less than 3 years old. Photos older than 3 years will not be returned.** Glamour photos, bikini photos, and sexual photos will not be used and will not be returned. Photos with your head and/or face cut off/covered or filters that distort or add false features will not be used. Maximum 3 photos with a basic application. Additional photos are \$1 each (3 first class Forever stamps for listed states). Photos sent after the application is processed are a revision. Payments are non-refundable. Put your name and ID number on photo(s) if you want them to be processed and returned. We will not get photos from online.

Any complaints (fraud, false information, etc.) will be evaluated for credibility. State Department of Corrections website, other websites and information available on the Internet may be used to evaluate complaints. If an accusation appears to us to be credible, the page may have a notice posted with the complaint and be added to our fraud section. Information and photos sent to Paper Dolls are checked when possible.

You may request to have your web page removed at any time. Your page will ONLY be removed at the request of the inmate listed on the page from her prison address. Paper Dolls staff may elect to remove any web page at any time for any or no stated reason. Pages with fraud notices will be removed only at the discretion of Paper Dolls staff.

Paper Dolls and its staff are not responsible for materials lost in the mail or by the prison or refused by the prison. All photos sent to us with a self-addressed, stamped envelope are returned when the web page is posted. Any mail returned to Paper Dolls for ANY reason will not be re-sent without a new self-addressed, stamped envelope being provided.

You may revise your profile and add photos. A self-addressed, stamped envelope is required to have anything returned. No chest-waist-hips measurements or other sexual content will be used. Profiles may be edited by Paper Dolls staff. Photo/profile revisions are \$5 each time, 10 stamps for listed states. Maximum 1 photo with profile change or 2 photos without profile change. Additional photos are \$1 apiece more. Page reprints are \$1 apiece, 3 stamps for listed states. Address, weight, outdate changes and info corrections are free but no printouts without the reprint fee.

Reprints of 4" x 6" photos from a professional photo service on photo paper are available. Minimum of 2 copies per single photo at a price of \$1 per pair. You must provide an envelope with sufficient postage to return photos. Check, money order, or cash; **NO STAMPS**. This price is subject to change and the service may be withdrawn at any time.

Electronic messaging (email) service allows people to write to you from your Paper Dolls page. Rates are \$5/month or \$50/year for unlimited email. **Cash, check, or money order ONLY** made out to Lee Vine: **NO STAMPS**. Rates and limits subject to change. Changes will not affect prior subscriptions. Messages will be printed and mailed once a week to the address on your web page. If you are in a BOP institution and have an electronic messaging subscription, send an invitation to PaperDolls@mail.com to have your messages be delivered through Corrlinks. Electronic messaging letters will be delivered through Corrlinks for women in Iowa. We will not respond to any messages to us through Corrlinks or JPay. No refunds. No guarantees that you will receive email. Anyone may pay for the subscription and anyone may use the service from your web page at no charge to them.

The **Daily Dozen** page costs \$5 per 2 months, \$25 per 12 months (cash, check, money order, or Paypal). Subscribers are sorted in random order and then displayed in a scrolling list.

Monthly page view tracking with how many times your page has been viewed, the dates and times, and where in the world the person is from. The price is \$5 per month, and we will send a printout of this info on the first of each month.
